Jefferson Financial Federal Credit Union is proud to announce the Peter C. Bertucci Scholarship Program. Mr. Bertucci, founder of the Credit Union, actively participated in the community's education by serving as teacher and administrator. He also served as Superintendent for the Jefferson Parish Public School System from 1969-1973.

The 2020 Scholarship Program will award twenty \$1,000 scholarships to members who demonstrate academic excellence, school/community involvement and are a member of the Credit Union. The Credit Union will also present the school of each recipient with \$300, and the sponsoring teacher/counselor of the student with \$100.

ELIGIBILITY

1. Graduating senior of the 2019-2020 school year
2. Current grade point average of 2.5 or higher
3. Enrolling in an accredited two-year or four-year college, university or vocational/technical school for the 2020-2021 academic year
4. Member of Jefferson Financial Federal Credit Union upon awarding

**Credit Union employees, children of Credit Union employees, board members and children of board members are NOT eligible to participate.*

- On a separate document, list membership (throughout your high school years only) in extracurricular clubs, sports, community service/volunteer organizations, church groups, work experience, etc. Denote the number of years participated and any leadership roles you held in each.
- Essay (less than 300 words) on "What is the biggest financial challenge facing high school students today, and what can Jefferson Financial do to combat this issue?"
- Two letters of recommendation from teachers or mentors who are not related to you (may be mailed separately)
